## **Business Arising:**

Will add information regarding trail fees/donations. Would like to set up an e-note subscription from the main page. Duncan to provide partnership agreement, strategic plan, and lease agreement for posting on website. Domain name needs to be renewed by November 2016. Need to assign someone to maintain Facebook page. Dave Wallensteen to email executive for contact info for website. Forward any questions/concerns re webpage changes to Dave Wallensteen.

Land Use Planning – Trails Committee - Dave Wallensteen. Met Nov 2 with members Debbie Phillips, Keith Cox, Dave Wallensteen, George Zorn and Duncan Moore. Would like updated administrative map. George Zorn will be looking into this.

**Cattle guard, range control and fencing** – there will be 3 cattle guards; fencing at the hunters view area. Cattle guard will not be an issue for track setter.

**Chainsaw Course** – course was held last Saturday. Brush cutter rental for trail maintenance was approved. Budget for the Safety committee was set at \$2500.

**Explorers Program** – Abbi May. only 4 kids have expressed interest. A potential leader has stepped forward - Abbi feel the program should only go forward if a minimum of 6 kids express interest.

**Treasurers Report**: Allan – getting trail fees sign made. Ski swap net approx. \$2800.

MOTION: Allan Bahen moved that the net proceeds from the ski swap up to \$2000 go to ski team then the remainder split 50/50. Seconded by SuzyBeckner. Passed.

Community gaming grant – currently have insufficient evidence to support a grant. Short form application submitted by deadline but additional supporting documentation was required within a two week window which was missed. Allan submitting an appeal but the appeal is only based on the information previously submitted – no new information can be submitted.

**Grant application to SASCU:** Ski team will not apply for this grant this year to leave option open to Chalet Expansion committee to apply if desired.
