Safety, increase appeal for working skiers, programs- jackrabbits, masters, ski teams. All surrounding ski areas already have lighting systems. Strategic plan includes a lighting plan which was discussed at the round table.

Trail plan- wider trails with interesting terrain up to 6km. See map -4 phase approach.

Underground wiring. LED lighting is more efficient and cost is improving. Solar is not practical. Poles -metal vs treated wood- they are continuing to research.

Environmental impact is being considered and wildlife impact assessment should be done prior.

Climate considerations – recent climate study from the chalet expansion project may be adequate.

Consultation with stakeholders including logging companies, rec sites and trails, swatsen nation prior is important.

An engineering plan is needed to proceed with further research and decisions. \$7,500 Kelowna company. PG company that just did 100mile lighting \$4-5,000.

Total cost may be \$100,000/km. There are grant opportunities. It would be nice to have a shelf ready project to go after the grants. We need a mandate from the society and a membership vote. Discussion about whether to come up with an engineered plan prior to getting approval from the membership. Randi requested a special meeting to get approval from the membership.

No plan to borrow money.

Will share engineered plan for membership input.

Ski team has \$6500 to donate.

Suzy motioned to put \$6500 raised from BC champs toward the lighting in a separate account. Craig 2nd.

Tentative date June 11. Suzy will book.
